

Tear Gland Treatment (TGT) / Lids & Lashes Therapy (LLT)

Assessment of your ocular surface has revealed **Evaporative Dry Eye** and/or **Blepharitis**. There are numerous symptoms associated with **Dry Eye Disease (DED)**; not everyone experiences symptoms that coordinate with the signs we see in your eyelids' glands. 86% of DED cases contain dysfunction in the glands that produce the oil layer of your tears. Since these meibum (tear oil) producing glands are called meibomian glands, this dysfunction is referred to as **Meibomian Gland Dysfunction (MGD)**. A common precursor to MGD is another eyelid disorder, Blepharitis — inflamed eyelids containing an overgrowth of micro-organisms along the lash line. Among other mechanisms, the biofilm produced by blepharitis can damage the eyelids' oil glands. Poorly functioning glands contribute to poor quality tears and when left without treatment, at-risk glands atrophy; treatment can improve the quality of the glands and preserve the quantity of healthy tears produced. After all, light enters your eye through the tear-film first on its way to provide sight; that's why DED and MGD are common causes of intermittent blur. The quality and volume of your tears are vital to the health of the “windshield” tissue through which we see the world, and maintaining a healthy ocular surface ensures you'll be able to **SEE YOUR BEST**.

Eyelid hygiene for at-home use to maintain healthy tears includes the following: an eye-safe **disinfectant** called hypochlorous solution to reduce the presence of any invading organisms, a **warm** compress to loosen the poor-quality meibum currently clogging your glands, a **cleanser** specially formulated for eyelids and eyelashes with tea tree oil that controls the demodex mite population, increased intake of EPA omega 3 fatty-acids that **replenish** the building blocks of the lipid tear layer; and prescription drops or PFAT's (Preservative Free Artificial Tears) designed to support your tears' oil layer when applicable. **In-office treatments/therapies** to return your glands to baseline include Tear Gland Treatment (TGT) with heat and expression of the glands performed by the doctor followed by Lids & Lashes Therapy (LLT) done with the technician while you enjoy a complimentary 3D Motion Infiniti Chair Massage. LLT can also be performed as a stand alone service. Specialized images of your glands documents the severity of MGD prior to treatment and along your recovery journey: **mild** is 100% reversible, **moderate** means there may be some gland “drop-out” and **severe** means you've lost more than ½ of your meibomian glands in any one eyelid. Please note that these are treatments, not a cure; if you cannot maintain the benefits at home, in-office treatments may need to be repeated. The initial severity and compliance with an at-home eyelid hygiene regimen prescribed by your doctor will dictate how well your eyes respond to the in-office treatment. It may take up to 2 weeks for your glands to recover from in-office expression at which time you'll start to feel relief.

TGT includes LLT and takes about 30 minutes; LLT is available as a stand alone subscription service or as a single global fee; any service pre-paid on the same day as it was prescribed comes with 1 FREE HTB (Healthy Tears Bundle) or \$40 Instant Savings; alternatively you may take advantage of the subscriptions savings or use the following **Benefit 4 Established Patients (B4EP): 4 Easy Payments** withdraws 1/4th payment upon signing and again every 2 weeks — paid in full 2 weeks after a 1 month medical follow up. Additional medical follow up visits may be prescribed.

The steps in a Tear Gland Treatment procedure are rather straightforward. **A medical device is used to deliver the appropriate level of heat for a full 10 minutes to loosen the contents of your eyelid glands.** Numbing drops will then be used on your eyes for your comfort, then the doctor will gently express your glands, remove the buildup that has threatened your eye health, and strip away any biofilm across the gland openings with a variety of handheld instruments. As with all procedures there are risks and it is not possible to list all of them here but common risks include: redness or swelling of the eyelids, temporary discomfort around the eyes, or mild skin irritation. You will be given clear instruction on what to do if you feel discomfort. The side effects of treatment are all far less severe than the damage dry eye causes to the ocular surface. Immediately following TGT the Lids & Lashes Therapy (LLT) consists of an in-office cleaning that is performed in our 3D Motion Infiniti Massage Chair along with a special cool down process. Continued use of your home eyelid hygiene products as well as any prescribed drops including medicines and/or PFAT's (Preservative Free Artificial Tears) is required to achieve long-lasting success following this in-office procedure.
